# **Head Coach/CEO Report**

- STAR Swimming Activities
  - -Hosted the first Super STAR Series Meet went well
  - -Hosted the Fall Classic over 350 athletes from the area, athletes did well supporting each other and the timeline was maintained
- CEO Priorities
  - -Met with VM about climate control and temperature of the pool
  - -Met with Co-Presidents
  - -Reserved bus for the Indy Trip in January, \$11,000: close to the same price from last year

- -Reserved the copier machine for meets
- -Met with Co-Meet Directors (5) (plan for future meets, expectations of the positions, etc...)
- -attended multiple college signings
- -met with J. Tedeschi about his media production roll
- Community Program
- Competitive Program
  - -Seniors focus on strength and injury prevention, very impressed with progress Getting ready to welcome back senior girls from the varsity season and transitioning senior boys to their varsity season
  - Morning practices are not yet established but will be explored if there is interest and commitment
  - -Dreaming adjusted well to increase in training throughout the season Good performance in the Fall Classic
  - Athletes will continue to focus on stroke and technique to prepare for the STAR Invite
  - -Learning learning athletes will start increasing intensity and there is a focus on technique and improving stroke, there has been good feedback to date
  - -Exploring focus on body position and progression through the strokes, focus on flip turns and starts
  - -Northtowns encouraging swimmers to take advantage of ECC practices when able, flyers went home to Sweet Home students and there has been good interest from the flyers discussion ensued about getting flyers to neighboring districts
